**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING A CONTRACT EXTENSION WITH GRUBBS EMERGENCY SERVICES, LLC. FOR EMERGENCY DEBRIS REMOVAL SERVICES ON AN AS NEEDED BASIS; AUTHORIZING THE CITY MANAGER TO EXECUTE THE EXTENSION ON BEHALF OF THE CITY AND TO EXPEND EMERGENCY FUNDS AS NEEDED; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City is currently under contract with Grubbs emergency Services, LLC on an As Needed basis for debris removal services thru a Piggyback contract from the City of Islamorada; and

**WHEREAS**, the contract allows for up to six additional years of contract extensions, of which six years have already been extended; and

**WHEREAS**, the City Manager recommends that the City Council extend the existing contract utilizing the same terms and pricing to provide comprehensive disaster recovery services to the City on an as-needed basis.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:**

**Section 1.** The above recitals are true and correct and incorporated herein.

**Section 2.** The contract extension between the City and Grubbs Emergency Services, LLC. for Emergency Debris Removal, a copy of which is attached as Exhibit "A," together with such non-material changes as may be acceptable to the City Manager and approved as to form by the City Attorney, are hereby approved. The City Manager is authorized to execute the extension and expend emergency funds as needed on behalf of the City.

**Section 3.** This resolution shall take effect immediately upon its adoption.

Dear Mr. Grubbs,

The City of Marathon's contract for Emergency Debris Removal Services with Grubbs Emergency Services, LLC. was entered into on July 26, 2010 (the "Contract"), and was for a three year term ending on July 20, 2013. Section 2(e) of the Contract provides for "an additional two additional three year to extend on behalf of the City..." for a total of up to nine years. The Marathon City Council approved a one-year extension to the Contract at its April 9, 2013 meeting, extending the Contract through July 20, 2014, and an additional two years on May 27, 2014. On June 14, 2016, the City Council approved a subsequent extension to the Contract until July 26, 2019. Accordingly, the City would like to extend the Contract for an additional three-year term, through July 26, 2019, at the originally contracted terms.
