A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVAL OF A PROPOSED RATE AND OR INCREASE IN THE MONTHLY WASTEWATER UTILITY RATE CHARGED TO EACH PROPERTY OWNER BY THE GREATER OF THE CPI-U (CONSUMER PRICE INDEX FOR ALL URBAN CONSUMERS), IN THE MIAMI, FORT LAUDERDALE AND FLORIDA AREA OR 1.0%; AUTHORIZING THE CITY MANAGER TO ADMINISTER WASTEWATER RATE IMPLEMENTATION ACCORDINGLY; AND PROVIDING AN EFFECTIVE DATE

**WHEREAS**, the City Council of the City of Marathon, Florida (the "City") enacted Ordinance 02-07-12 and Ordinance 2008-10 (the "Ordinances), which establish a Wastewater Utility and authorizes, by City Council resolution, the imposition of fees, charges procedures as appropriate to the construction, operation and maintenance of the wastewater system;

**WHEREAS**, the City enacted Resolution 2009-60 establishing a Wastewater Utility Rate Schedule Exhibit "A"; and

**WHEREAS**, the City Council enacted Resolution 2015-106 amending the Wastewater Utility Rate Schedule Exhibit "A" for the City's Wastewater Utility to include an annual rate index.

WHEREAS, the City Council desires to authorize the city manager to administer the wastewater rate implementation commencing on October 1, 2016.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AS FOLLOWS:

- Section 1. The above recitals are true and correct and are incorporated herein.
- Section 2. This resolution is adopted pursuant to the provisions of Ordinance No. 02-07-12, Sections 166.021 and 166.041, Florida Statutes, and other applicable provisions of law.
- Section 3. The City shall adjust the Wastewater Utility Rate Schedule Exhibit "A" annually. Before October 1<sup>st</sup> of each year, beginning October 1, 2016. The rates shall be increased by the greater of 1) the Consumer Price Index for all urban consumers (CPI-U) in the Miami Fort Lauderdale, Florida area as published by the Bureau of Labor Statistics for the prior 12 months ending the June of the same year, or 2) 1.0%. Rates shall be rounded to the nearest \$0.01.
  - Section 4. This resolution shall take effect immediately upon its adoption.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AS FOLLOWS:

- Section 1. The above recitals are true and correct and are incorporated herein.
- Section 2. This resolution is adopted pursuant to the provisions of Ordinance No. 02-07-12, Sections 166.021 and 166.041, Florida Statutes, and other applicable provisions of law.
- Section 3. The City shall adjust the Wastewater Utility Rate Schedule Exhibit "A" annually as follows as directed by the City Council. Before October 1st of each year, beginning October 1, 2016, the Wastewater Rates shall be reviewed and staff will recommend to Council weather an increase is needed for the following fiscal year. If Council approves an increase at that time then the rates shall be increased by the greater of 1) the Consumer Price Index for all urban consumers (CPI-U) in the Miami Fort Lauderdale, Florida area as published by the Bureau of Labor Statistics for the prior 12 months ending the June of the same year, or 2) 1.0%. Rates shall be rounded to the nearest \$0.01.
  - Section 4. This resolution shall take effect immediately upon its adoption.

Section 5: To the extent this Resolution conflicts with Resolution 2015-60, this Resolution shall prevail.



The effect of a wastewater rate index on the financial forecast is discussed below in terms of annual debt service coverage.

#### SUMMARY OF DEBT SERVICE COVERAGE

The City has entered into several SRF loan agreements to fund the wastewater and stormwater infrastructure. The covenants within these loan agreements include several provisions, including
