A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, RATIFYING A CONTRACT WITH WINDSTREAM FOR INTERNET AND LAND LINE PHONE SERVICES; AUTHORIZING THE CITY MANAGER TO ENTER INTO AGREEMENTS IN CONNECTION THEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City has contracted with Windstream for their phone and internet service for many years; and

WHEREAS, the City staff wishes to expand the contracted services to enable our network to run smoother and facility productivity; and

WHEREAS, the City staff recommends the Council approve the agreement of the services set forth on Exhibit "A," attached hereto; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and incorporated herein.

Section 2. The City Council hereby approves the ratification of the contract agreement set forth in Exhibit "A," attached hereto and incorporated herein, and the City Manager is authorized to expend budgeted funds in connection with this agreement.

Section 3. This resolution shall take effect immediately upon its adoption.
