A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, RATIFYING EMERGENCY WORK AUTHORIZATIONS FOR VENDORS UNDER EXISTING CONTINUING SERVICE AGREEMENTS AS LISTED IN EXHIBIT A; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Governor, Monroe County and the City of Marathon were under a emergency declaration during the time the emergency work authorizations were signed; and

WHEREAS, Section 2-184 provides for exemptions to the purchasing policy for purchases arising out of or because of emergencies when a situation, occurrence or matter necessitating immediate or quick action and not permitting adequate time to utilize the competitive bidding process; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, that:

Section 1. The above recitals are true and correct and incorporated herein

Section 2. City Council hereby approves the purchases set forth on Exhibit A hereto.

Section 3. The City Manager or designee is authorized to execute any agreements in connection with these emergency work authorizations and expend funds on behalf of the City.

Section 4. This resolution shall take effect immediately upon its adoption.
