RESOLUTION 2013-56**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING A TWO YEAR EXTENSION TO THE AGREEMENT BETWEEN THE CITY AND SEAMAR DIVERS, LLC FOR MOORING INSPECTION AND CLEANING SERVICES IN THE BOOT KEY HARBOR MOORING FIELD; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Marathon, Florida (the “City”) and Seamar Divers, LLC (“Seamar”) entered into an agreement (the “Agreement”) under which Seamar currently provides mooring inspection and cleaning services for the Boot Key Harbor Mooring Field in Marathon, and;

**WHEREAS**, the City wishes to extend the Agreement upon the existing terms and conditions for the second of the two extensions set forth in in Section 2.1 of the Agreement (two inspections per year and cleaning of all moorings for the annual sum of \$15,998.54).

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:**

**Section 1.** The above recitals are true and correct and incorporated herein.

**Section 2.** A two year extension of the Agreement between the City and Seamar for the provision of mooring inspection and cleaning services in the Boot Key Harbor is hereby approved. The City Manager is authorized to expend budgeted funds on behalf of the City

**Section 3.** This resolution shall take effect immediately upon its adoption.




Re: Twice Yearly Mooring Inspection and Cleaning for 226 Moorings in Boot Key Harbor Mooring Field

Dear Mr. Anaya,

Pursuant to section 4.3 in the Professional Services Agreement between the City of Marathon and Seamar Divers, LLC, dated December 13, 2011, the City may extend the agreement for an additional term of two, one (1) year extensions upon written notice from the City Manager to the Contractor. The City Council approved a two (2) year extension in lieu of the final one year extension at the July 23, 2013 meeting.

The City of Marathon wishes to extend the agreement for two years from December 13, 2013 to December 13, 2015. This extension is effective upon receipt of this written notice. The total annual cost to the City will be \$15,998.54 for two inspections and cleanings for each year.
