A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING A GRANT APPLICATION TO THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION, BUREAU OF BEACHES AND COASTAL SYSTEMS TO PROVIDE FUNDING FOR AN ANTICIPATED 50% OF THE REQUIRED LOCAL MATCH FOR THE HURRICANE ISAAC RESTORATION PROJECTS, BEACH SURVEYS AND INVASIVE PLANT REMOVAL/NATIVE DUNE PLANT REPLACEMENT AT SOMBRERO AND COCO PLUM BEACHES; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City is the entity responsible for the maintenance and preservation of Sombrero and Coco Plum Beaches and supports the permitting, design, construction, and monitoring of beach projects and is willing to serve as the local sponsor for beach projects and has identified funding in its capital improvement budget for beach projects; and

WHEREAS, The Florida Department of Environmental Protection, Division of Water Resource Management is accepting funding requests from Florida local governments for the FY 2014-2015 Beach Management Funding Assistance Program; and

WHEREAS, pursuant to Resolution No. 2013-03; the Council approved State of Florida Division of Emergency Management Agreement No. 13-IS-3S-11-54-01-534 for Hurricane Isaac Beach Projects; and

WHEREAS, it is anticipated that fifty percent of the City's match portion of the Hurricane Isaac Restoration Projects is eligible for the FDEP funding.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

- **Section 1**. The above recitals are true and correct and incorporated herein.
- **Section 2**. The City Council authorizes the City Manager to submit a Florida Department of Environmental Protection Bureau of Beaches and Coastal Systems Program grant application and administer the grant on behalf of the City of Marathon.
 - **Section 3**. This resolution shall take effect immediately upon its adoption.
