CONDEMNING RACISM AND REAFFIRMING MARATHON'S
COMMITMENT TO FIGHT FOR RACIAL JUSTICE AND
HUMAN AND CIVIL RIGHTS FOR ALL; AND PROVIDING FOR
AN EFFECTIVE DATE.**

WHEREAS, The City of Marathon, its Mayor, City Council, Sheriff Rick Ramsay and the entire Monroe County Sheriff's Office, and Marathon staff and employees city-wide, are deeply saddened by the tragic events that have recently occurred across the country; and

WHEREAS, racism and hate have no place in our city and we are committed to working actively against all forms of racism. We are committed to safeguarding our community against the damages that racism causes and to ensuring that the Constitutional rights of every person who lives, works, and visits our great city are protected; and

WHEREAS, true Marathon citizens oppose racism in any form, anywhere it exists, reaffirming that people of all races, ethnicities, cultures, and faiths contribute to Marathon's strength and well-being; and

WHEREAS, the City of Marathon truly appreciates the overwhelming support we receive daily from this great community, and it is our promise to each of you that we will work diligently every day to exceed your expectations in all aspects of city-wide operations, including law enforcement duties provided by the Monroe County Sheriff's Office; and

WHEREAS, the City of Marathon, the Monroe County Sheriff's Office oppose police brutality in any form.

OF MARATHON, FLORIDA, THAT:**


