

**CITY OF MARATHON, FLORIDA
RESOLUTION 2021-33**

A RESOLUTION OF THE CITY OF MARATHON, FLORIDA, GRANTING THE CITY OF KEY COLONY BEACH THE AUTHORITY TO REGULATE PARKING, LANDSCAPING AND OTHER MUNICIPAL FUNCTIONS WITHIN THE RIGHT-OF-WAY KNOWN AS CORAL LANE, A PART OF BOTEL SUBDIVISION, FAT DEER KEY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, there is a question of jurisdiction and ownership between the City of Marathon and the City of Key Colony Beach as that relates to Coral Lane; and

WHEREAS, the issue arises as all of the houses on Coral Lane (Botel Subdivision) are within the City of Key Colony Beach, the two cities have typically shared jurisdiction for management of the street; and

WHEREAS, Coral Lane has an associated Real Estate number in the name of the City of Marathon; and

WHEREAS, Coral Lane is not shown as one of the streets turned over by the County to the City upon incorporation. In fact, Botel Subdivision “splits” down the middle of Coral Lane, the street that creates the effective boundary between the cities; and

WHEREAS, finally, Key Colony Beach actually owns the utilities on Coral Lane, part of which would be on the City of Marathon side of the street; and

WHEREAS, Key Colony Beach wishes to manage, at a minimum, parking and landscaping along that street; and

WHEREAS, they are seeking the City of Marathon’s approval to manage the street for these purposes as well as other issues, should they arise – garbage, signage, other municipal functions,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and incorporated herein.


Section 2. Provides approval to the City of Key Colony Beach, at their request, to manage all of the Right-Of-Way on Coral Lane for functions such as parking, landscaping, garbage, signage, other municipal functions.

Section 3. The City Clerk is directed to transmit a certified copy of this Resolution to the City of Key Colony Beach, Mayor and City Administrator.

Section 4. Effective Date. This Resolution shall become effective immediately upon its adoption.
