ORDINANCE 2007-02**

**AN ORDINANCE OF THE CITY OF MARATHON,  
FLORIDA, REPEALING ORDINANCE 00-09-08  
REGARDING THE COLLECTION AND DISPOSAL OF  
SOLID WASTE WITHIN THE CORPORATE LIMITS OF  
THE CITY; PROVIDING FOR SEVERABILITY AND;  
PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, on September 26, 2000, the City Council of the City of Marathon (the "City") adopted Ordinance 00-09-08, providing for assumption by the City of the collection and disposal of solid waste within the corporate limits of the City; and

**WHEREAS**, pursuant to Resolution 02-07-90 adopted on July 30, 2002, the City Council subsequently requested that Monroe County continue to provide for the collection, transfer and disposal of solid waste within the City; and

**WHEREAS**, the City Council wishes to repeal the Ordinance 00-09-08 so as to accurately reflect that Monroe County continues to provide for the collection and disposal of solid waste in the City.


**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AS FOLLOWS:**

**Section 1.** Ordinance 00-09-08 is hereby repealed and is of no further force or effect.

**Section 2.** The provisions of this Ordinance are declared to be severable and if any section, sentence, clause or phrase of this Ordinance is held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, clauses, and phrases of this Ordinance but they shall remain in effect, it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.
