

RESOLUTION NO. 00-10-65

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AUTHORIZING THE TEMPORARY CLOSING OF U.S. HIGHWAY #1 AND CERTAIN LOCAL STREETS TO ALLOW RESIDENTS TO PARTICIPATE IN THE MARATHON HIGH SCHOOL ANNUAL HOMECOMING PARADE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Marathon High School Annual Homecoming Parade will require the use of U.S. Highway #1 and certain local streets; and

WHEREAS, the success of the event depends on the ability of the residents to have access to the location and participate in the event; and

WHEREAS, the City Council supports the closing of the roadways for this event by the appropriate governing jurisdictions of the particular roadways.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, AS FOLLOWS:

Section 1. The above recitals are incorporated into this Resolution.

Section. 2. The "Request for Temporary Closing/Special Use of State Road" application describing the proposed route and detour route, attached as Exhibit 1, is supported by the City Council.

Section. 3. This Resolution shall be effective on the date of the event, November 9, 2000 only, or an alternate date should one be required.

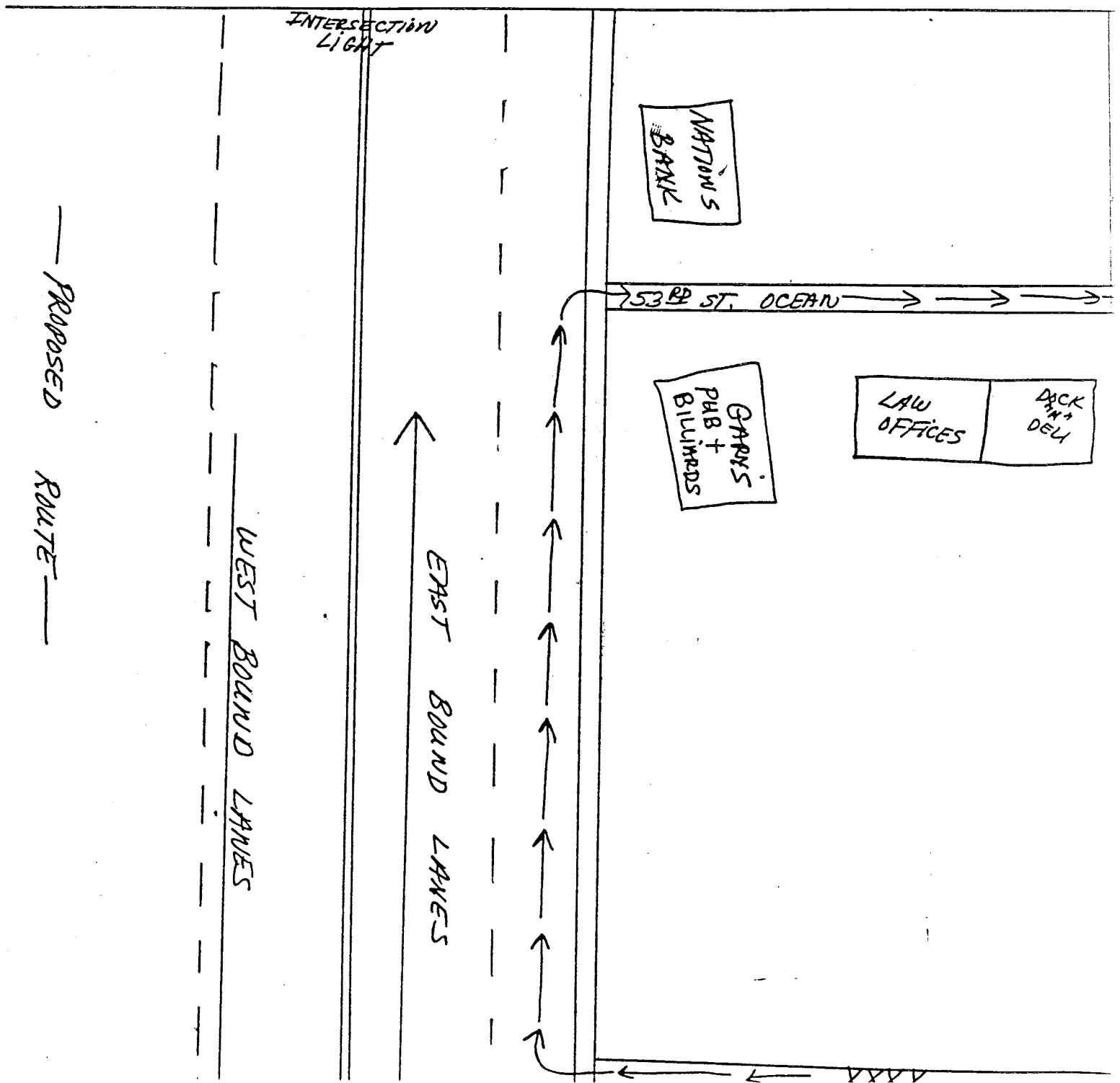

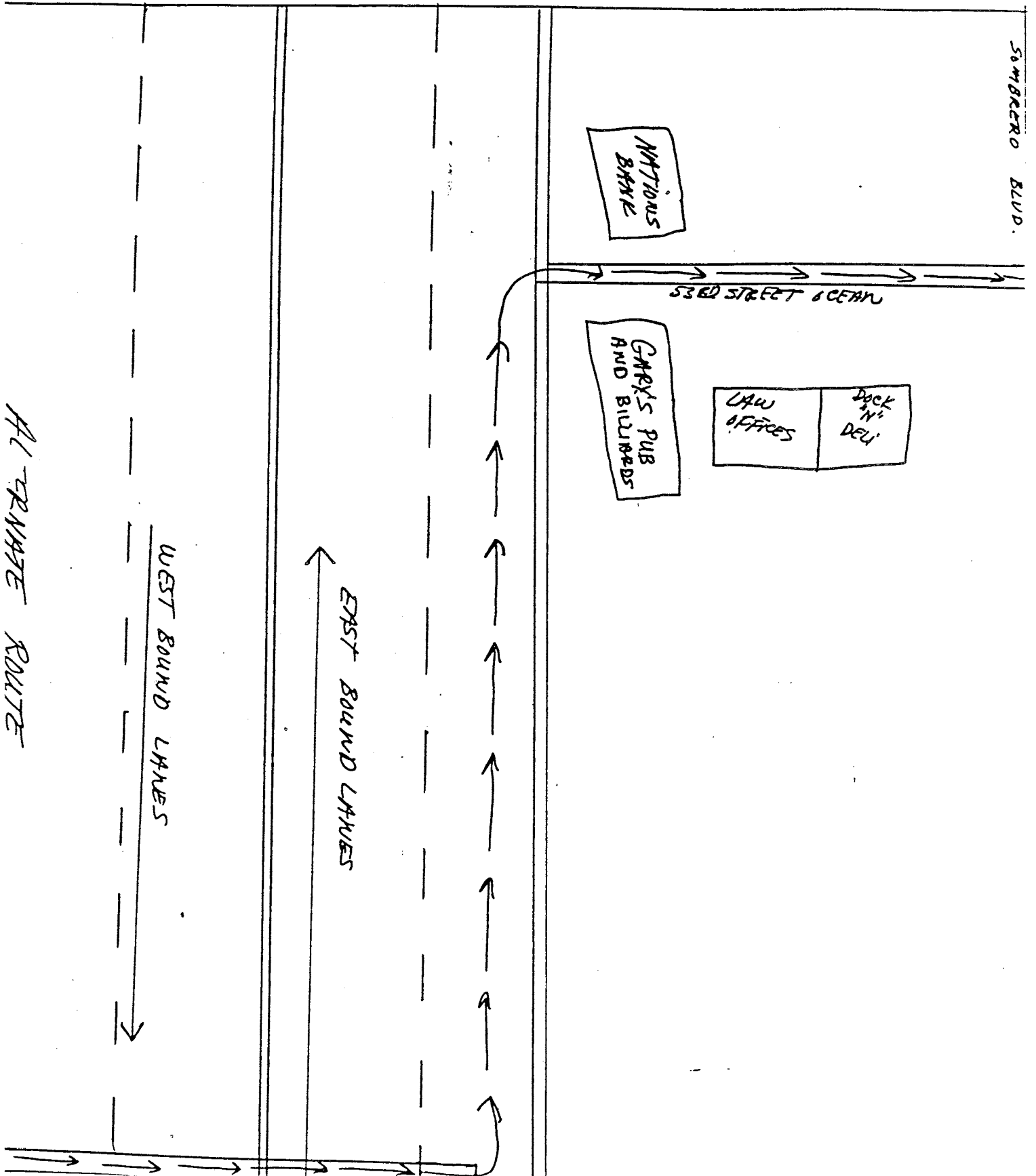


SOMBRERO BEACH ROAD
