RE: Semi-Annual Report in FOLKS v. City of Marathon

To Whom It May Concern:

Please be advised that this correspondence hereby provides the Semi-Annual Report of the City of Marathon's Deep Injection Well consistent with the Consent Degree in the above-referenced case.

Area 3, 4 & 5 Design, Permitting and Construction Administration

- 1. PSA approved via Resolution 2024-33. This project includes design of the effluent force main from the Area 3, 4 and 5 WWTPs to the DIW site at Area 6
- 2. Modeling of the force main has been completed
- 3. FDEP permitting drawings completed for force main and permit application submitted to FDEP on 1/27/2025
- 4. FDOT permitting set under final review as of 1/30/2025. Will submit application expected by 2/14/2025
- 5. Construction bid package is in final review. Expect publication of bid expected by 2/14/2025
- 6. Design of the effluent pumping station at the WWTPs is under way. Pump selection has been completed.

Area 6 Design, Permitting and Construction Administration

- 1. PSA approved via Resolution 2024-34. This project includes design of the effluent force main from Vaca Cut to the Area 6 DIW site and design of the effluent holding tank and the electrical building.
- 2. Modeling of the force main has been completed.
- 3. Preliminary routing of the effluent force main is completed.
- 4. FDEP permitting drawings are near completion, expect to submit FDEP permitting package by 2/21/2025

Area 7 Design, Permitting and Construction Administration

- 1. PSA approved via Resolution 2024-35. This project includes design of the effluent force main
- 2. Modeling of the force main has been completed
- 3. FDEP Permitting drawings are under final review. The FDEP application package is under final review prior to signing and sealing.
- 4. The FDOT permitting set is under in final design, under review at this time.
- 5. The Construction bid package is near completion, with the ITB and technical specifications completed and under review.
- 6. Design of the effluent pumping station is in the preliminary design phase. Pump selection has been made.

Deep Injection Well Design, Permitting and Construction Administration

- 1. Weiler Engineering prepared a Request for Qualifications for design, permitting and construction administration for the deep injection well and the deep injection well pumping station.
- 2. The Request for Qualifications was published by the City. Water Science Associates was selected to perform this task. Award was authorized under Resolution 2024-129 on 12/10/24.
- 3. The scope of work for WSA includes design and permitting of the deep injection well and the required monitoring wells and design & permitting of the DIW pumping station. WSA will provide the required professional to observe and log the deep well borings and soils classifications during construction.
